

Overview – How the Program Works

1. Select the entire suite or just the program(s) you need.
2. IAS will work with you to ensure that companies performing work in your jurisdiction, under the program(s) you have selected, are accredited by IAS.
3. Verifying that a company meets the requirements is as simple as verifying that it has a current IAS certificate of accreditation and that its scope covers the work it is doing in your jurisdiction. It can all be done in a matter of seconds.
4. Once a company is accredited, you can access its certificate of accreditation on the IAS website. Many companies are already accredited by IAS. You can easily find a list of all accredited companies on the IAS website at www.iasonline.org.

Join Other Building Departments and ICC Chapters

What is the IAS Accreditation Suite for Building Departments?

Approval Support.

It is a group of accreditation programs that help you verify the competence of companies such as structural fabricators, special inspection agencies, and laboratories working in your jurisdiction.

Easy Access.

It provides you with free, online access to accreditation certificates to verify the scope of qualifications and status of accredited companies. These are the basis for your approval.

Code Official Oversight.

It provides you with accreditation programs that have been developed with oversight from code officials. The companies pursuing accreditation are evaluated by IAS technical and subject matter experts. Periodic onsite assessments are part of the process to verify that accredited companies continue to meet accreditation and code requirements.

How can the Accreditation Suite be free for Building Departments?

Building departments can use the Accreditation Suite for free because the costs are being paid by the companies that get accredited by IAS. Accreditation provides value to these companies in several ways including cost savings and revenue gains made through improvements, reduction in errors, marketing, regulatory approvals, etc.

How do you verify that a company is accredited by IAS?

1. Visit the IAS website, www.iasonline.org
2. Click on Find Accredited Organizations
3. Search for the Organization Name
4. View its Certificate of Accreditation
5. Each Certificate of Accreditation provides details about the work a company is qualified to perform

Eight Programs to Help Your Building Department Implement Code Requirements

– Use the entire accreditation suite of programs or just the ones that meet your needs.

- 1 **Special Inspection Agency Accreditation.** Your building department can approve special inspection agencies with confidence when you require them to become accredited by IAS. Comprehensive evaluations and ongoing assessments help ensure agencies are qualified to perform inspections in your jurisdiction based on requirements in IBC Chapter 17 and IAS accreditation criteria.
- 2 **Fabricator Accreditation.** Get verification that the in-house inspection programs of fabricators (steel, concrete, wood) are in compliance with IBC Section 1704.2.2. After doing a thorough initial evaluation, IAS provides continuous oversight with quarterly, unannounced onsite inspections.
- 3 **Metal Building Systems Accreditation.** You will know that the inspection programs of metal building manufacturers are in compliance with IBC Chapter 17 when you require IAS accreditation. The program addresses fabrication and shop practices, materials certification, quality management system elements for engineering, personnel, process control, and technical requirements.
- 4 **Metal Building Assemblers Inspection Accreditation.** Have confidence that metal buildings accordance with code, specifications, costs and deadlines. IAS assesses the assemblers management includes the assembly processes, internal safety, training programs, periodic jobsite inspections, etc. It's the benchmark for companies qualified to assemble and erect metal buildings.
- 5 **Testing Laboratory Accreditation.** Make sure that the test reports used in your jurisdiction are from qualified laboratories. Our comprehensive evaluations, based on ISO/IEC 17025, verify that laboratories are technically competent and qualified to perform testing based on evaluation of their equipment, personnel, quality control procedures, and operations.
- 6 **Field Evaluation Body Accreditation.** When you encounter the installation of a custom, one-of-a kind appliance for which no equivalent standards exist, the IAS Field Evaluation Body (FEB) accreditation program is an uncomplicated way to ensure that the intent of the code is satisfied. Covering everything from a simple pizza oven to a complex shipyard crane, IAS-accredited FEBs offer an additional measure of confidence as they conduct safety evaluations onsite. The FEB accreditation is based on NFPA Standards 790 and 791, as well as ISO/IEC 17020.
